Overview of Climate Change Activities

The Lao PDR has been recognized as one of the countries that are most vulnerable to climate change and its impacts due to its particularly high dependence on climate-sensitive natural resources and low adaptive capacity and decided to:

- In 1995 the GOL joined the global community by ratified the United Nations Framework Convention and ratified the United Nations Framework Convention on Climate Change (UNFCCC)
- Established the National Steering Committee on Climate Change (NSCCC) and the Technical Working Groups (TWG) 2008
- 2009 the country released the National Adaptation Plan of Action (NAPA) which contains a total of 45 priority projects totalling US\$ 85 million that will help first the initially identified four priority sectors namely agriculture, forestry, water and water resources and health to adapt to climate change.

Lao PDR Intended Nationally Determined Contributions (INDC) 2016 -2017

1. To identify and support implementation of Lao PDR's contributions to the post-2020 global climate agreement (Intended Nationally Determined Contributions – INDC);
2. To strengthen Lao PDR's engagement in the UNFCCC negotiation process leading to the post-2020 agreement.

Expected Output:

Low emission climate resilient programmes in key sectors (agriculture, water resources and forestry); Government and community response to emergencies and adaptation to climate change strengthened; Women's organizations systematically engaged in dialogue on adaptation and mitigation strategies.

Key stakeholders:

- Government Ministries and Agencies across the sectors of environment, forestry, agriculture, finance, transportation, energy
- Gender-based agencies such as Lao Women's Union (LWU) and the National Commission for the Advancement of Women (NCAW)
- Representation of other groups such as the Lao Youth Union
- International and National Non-Governmental Agencies (NGO's)
- Development Partners
- Other UN Agencies
